#ARTICLE II: PURPOSES

ARTICLE I: NAME

The name of this association is the Grady HS PTSA Parents and Teachers Association, Atlanta, Georgia. It is a local PTA/PTSA

organized under the authority of the Georgia Congress of Parents and Teachers, a branch of the National Congress of Parents and

Section 1. The purposes of the PTA are:

- a. To promote the welfare of children and youth in home, school, community, and place of worship;
- b. To raise the standards of home life;
- c. To secure adequate laws for the care and protection of children and youth;
- d. To bring into closer relation the home and the school, that parents and teachers may cooperate intelligently in the education of children and youth; and
- e. To develop between educators and the general public such united efforts as will secure for all children and youth the highest advantages in physical, mental, social, and spiritual education

Section 2. The purposes of the PTA are promoted through an advocacy and educational program directed toward parents, teachers, and the general public; developed through conferences, committees, projects, and programs; and are governed and qualified by the basic policies set forth in Article III.

Section 3. The association is organized exclusively for the charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code (hereinafter "Internal Revenue Code").

#ARTICLE III: BASIC POLICIES

The following are basic policies of National PTA and the Georgia PTA:

- a. The association shall be noncommercial, nonsectarian, and nonpartisan;
- b. The association shall work with the schools and community to provide quality education for all children and youth and shall seek to participate in the decision-making process establishing school policy, recognizing that the legal responsibility to make decisions has been delegated by the people to boards of education, state education authorities, and local education authorities;
- c. The association shall work to promote the health and welfare of children and youth and shall seek to promote collaboration between parents, schools, and the community at large;
- d. No part of the net earnings of the association shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons except that the association shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof;
- e. Notwithstanding any other provision of these articles, the association shall not carry on any other activities not permitted to be carried on (i) by an association exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (ii) by an association, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code:
- f. Upon the dissolution of the association, after paying or adequately providing for the debts and obligations of the association, the remaining assets shall be distributed to one or more nonprofit funds, foundations, or associations that have established their tax-exempt status under Section 501(c)(3) of the Internal Revenue Code and whose purposes are in accordance with those of the National PTA; and
- g. The association or members in their official capacities shall not, directly or indirectly, participate or intervene (in any way, including the publishing or distributing of statements) in any political campaign on behalf of, or in opposition to, any candidate for public office; or devote more than an insubstantial part of its activities to attempting to influence legislation by propaganda or otherwise.

#ARTICLE IV: RELATIONSHIP WITH NATIONAL PTA AND GEORGIA PTA

Section 1. This local PTA/PTSA shall be organized and chartered under the authority of the Georgia PTA in the area in which this local PTA/PTSA functions, in conformity with such rules and regulations, not in conflict with the National PTA Bylaws or the Georgia PTA Bylaws.

- office by dates designated by the National PTA;
- c. Has bylaws approved according to the procedures of its state;
- d. Submits annual audit report to the state office by the last business day of September; and e. Shall submit annually to the Internal Revenue Service (IRS), the appropriate Form 990 by the applicable IRS due

Section 4. The articles of association of this local PTA/PTSA include:

- a. Bylaws of such association; and
- b. Articles of incorporation of such association (in cases in which the association is incorporated). Section 5. This local PTA/PTSA shall adopt such bylaws for the government of the association as may be approved by the Georgia
- PTA. Such bylaws shall not be in conflict with the National PTA Bylaws or the Georgia PTA Bylaws.
- Section 6. The purposes and basic policies of National PTA shall in every case also be the purposes and basic policies of each constituent association.
- Section 7. Each member of the Board of Directors of this local PTA/PTSA shall be a member of this local PTA/PTSA.
- Section 8. Voting by proxy, absentee ballot, telephone, fax, e-mail and text messaging by members of this local PTA/PTSA shall be prohibited.
- Section 9. A PTA member shall not serve as a voting member of this local PTA/PTSA board while serving as a paid employee of or under contract to this local PTA/PTSA.
- Section 10. The Georgia PTA may determine the membership year for the local PTAs/PTSAs within Georgia. Only members of this local PTA/PTSA who have paid dues for the current membership year may participate in the business of this local PTA/PTSA.
- Section 11. The members of the nominating committee for officers of this local PTA/PTSA shall be elected by the general membership, and must be a member of this PTA/PTSA.

Section 12. This local PTA/PTSA shall keep such permanent books of account and records:

- a. Sufficient to establish the items of gross income, receipts, and disbursements of the association;
- b. Specifically including the number of its members, the dues collected from its members and the amounts of dues remitted to the Georgia PTA; and
- c. Such books of account and records shall at all reasonable times be open to inspection by an authorized representative of the Georgia PTA or by a duly authorized representative of the National PTA.

Section 13. Dissolution by Board of Directors and members of a Local unit:

- a. The Board of Directors of this local unit shall notify Georgia PTA in writing of the proposed dissolution meeting thirty (30) days prior to notifying each member.
- The notice must state that the purpose, or one of the purposes, of the meeting is to consider dissolving the association per Georgia Code for nonprofits.
- The proposal to dissolve shall be approved by 2/3 {two-thirds} of the general membership.
- Section 14. The charter of this local PTA/PTSA shall be subject to withdrawal and the status of such association as a local PTA/PTSA shall be subject to termination, in the manner and under the circumstances provided by the bylaws of the Georgia PTA.
- Section 15. This local PTA/PTSA is obligated, upon withdrawal of this charter by the Georgia PTA: a. To yield up and surrender all of its books and records and all of its assets and property to the Georgia PTA or to
 - such agency as may be designated by the Georgia PTA or to another local PTA/PTSA organized under the authority b. To cease and desist from the further use of any name that implies or connotes association with the National PTA or
 - c. To carry out promptly, under the supervision and direction of the Georgia PTA, all proceedings necessary or
 - To carry out promptly, under the supervision and desirable for the purpose of dissolving this PTA/PTSA which includes the loss of the PTA's/PTSA's 501(c)(3)

status.

Section 16. This local PTA/PTSA shall include in its bylaws provisions corresponding to the provisions of state bylaws identified

ARTICLE V: MEMBERSHIP AND DUES

#Section 1. Every individual who is a member of this local PTA/PTSA is, by virtue of that fact, a member of the National PTA and or the Georgia PTA by which this local PTA/PTSA is chartered, and is entitled to all the benefits of such membership. or the Georgia PIA by which this local riverion is character, and supports the #Section 2. Membership in each local PTA shall be open, without discrimination, to anyone who believes in and supports the

- #Section 3. This local PTA/PTSA shall conduct an annual enrollment of members but may admit individuals to membership at any 120 121 #Section 4. Each member of a local PTA/PTSA shall pay annual dues as may be determined by the association. The amount of the 122
- dues shall include the portion payable to the state PTA as determined by the state, and the portion payable to the National PTA as 123 124
- recommended by the Board of Directors and approved by 2/3 majority of the voting body at the National PTA annual convention. 125
- #Section 5. The national portion of each member's dues shall be two dollars, twenty five cents (\$2.25) per annum.
- 126 #Section 6. The Georgia PTA portion of each member's dues shall be one dollar and fifty cents (\$1.50) per annum.

- Section 7. Each member of this local PTA/PTSA shall pay annual dues of \$5.00 to said association. The amount of such annual dues shall include the portion payable to the Georgia PTA and the portion payable to the National PTA. 128

- #Section 8. The state and national portions of the dues paid by each member of this local PTA/PTSA shall be set aside by this local 130 PTA/PTSA and remitted to the Georgia PTA on a monthly basis. Each state PTA shall pay to the National PTA the amount of the 131 national portion of dues paid by all members of local PTAs/PTSAs in its area. 132

#Section 9. The Georgia PTA does not allow family memberships.

Please note: The Parliamentarian is not elected but is appointed by the President.

#Section 2. Each individual officer and individual co-officers shall have a vote.

Section 3. Officers shall be elected in the month of April.

#Section 4. The vote shall be conducted by ballot. When there is but one candidate for an office, the ballot for that office may be dispensed with and election held by voice vote. A majority vote shall be required for election.

#Section 5. The following provisions shall govern the qualifications and eligibility of individuals to be officers of this PTA/PTSA:

- a. Each officer shall be a member of this local PTA/PTSA:
- b. No officer may be eligible to serve more than two consecutive terms in the same office.
- c. A person who has served in an office for more than one half of a full term shall be deemed to have served a full term in such office; and
- d. No member shall serve as a council president while serving as a local unit president.
- Section 6. Officers shall assume their official duties following the close of the school year and serve for a term of 1 year(s) or until their successor is elected.

#Section 7. A vacancy occurring in any office shall be filled for the unexpired term by a person elected by a majority vote of the Board of Directors, notice of such election having been given to the Board of Directors. In case a vacancy occurs in the office of president, the first vice-president shall serve notice of the election.

Section 8. There shall be a nominating committee composed of 5 members (must be an uneven number) and 1 alternates who shall be elected by this local PTA/PTSA at a regular general membership meeting at least one month prior to the election of officers, as outlined in Article VI, Section 3.

- a. All members of the nominating committee shall be a member of this PTA/PTSA.
- b. The committee shall elect its own chair.
- c. The nominating committee shall nominate an eligible person for each office to be filled and report its nominees at the regular general membership meeting in April at which time additional nominations may be made from the floor. (Note: Must be the same month in #ARTICLE VI: OFFICERS AND THEIR ELECTION, Section 3)
- d. Only those individuals who are current members of this local PTA/PTSA and who have signified their consent to serve if elected shall be nominated for, or elected to, such office.
- e. The president is not eligible for election to the nominating committee.
- f. The principal is eligible to serve if elected.

#Section 9. The slate of proposed officers shall be posted in the school office at least ten (10) days prior to the election meeting.

- a. Preside at all meetings of this local PTA/PTSA; b. Serve as an ex officio member of all committees except the nominating committee; c.  - j. Perform such other duties as may be provided for by these bylaws, prescribed by the parliamentary authority, or directed by the Board of Directors or Executive Committee.

Section 2. The vice president(s) shall:

- a. Act as aide(s) to the president;
- b. In their designated order perform the duties of the president in the president's absence or inability to serve; and
- c. Perform such other duties as may be provided for by these bylaws, prescribed by the parliamentary authority, or directed by the president, the Board of Directors, or the Executive Committee.

- a. Record the minutes of each general, Executive Committee and board meeting of this PTA/PTSA;
- b. Read or distribute printed copies of the minutes of the previous meeting for approval;
- c. Maintain an accurate membership list as provided by the membership chair or committee;
- d. Have a current copy of the bylaws;
- e. Have minutes from previous meetings for reference at each meeting;
- f. Determine the presence of a quorum prior to any business being conducted,
- g. Call the meeting to order in the absence of the president and vice-president(s), unless the bylaws specify otherwise, and preside until a temporary chair is elected:
- h. Immediately upon the election of new officers, send a list of their names, addresses and phone numbers to the state PTA office, district director and council president (if applicable);
- i. Register their signature at the bank as an emergency signatory;
- j. Submit the names of the voting delegates and their alternates to the council PTA prior to the first council meeting, if local PTA/PTSA is a member of a council PTA; and
- k. Perform such other duties as may be provided for by these bylaws, prescribed by the parliamentary authority, or directed by the president, the Board of Directors or the Executive Committee.

Section 4. The treasurer shall:

- a. Have custody of the funds of this local PTA/PTSA;
- b. Maintain a full account of the funds of this local PTA/PTSA;
- c. Make disbursements as authorized by the president, or Board of Directors of this local PTA/PTSA in accordance with the budget adopted by this local PTA/PTSA;
- d. Have checks or vouchers signed by two people: the treasurer and one other person. Individuals authorized to sign checks shall not be related to each other by marriage or any other relationship;
- e. Never sign a blank check:
- f. Pay all bills by check never by cash;
- g. Never deposit funds of this PTA in a personal account or a school account;
- h. Always issue a receipt for cash received:
- i. Maintain a full and accurate account of the receipts and disbursements in the books belonging to this PTA/PTSA;
- j. Be prepared to answer all questions promptly and to have records available at all meetings;
- k. Provide a written financial statement at each meeting of the general membership, Board of Directors and Executive Committee:
- I. Present an annual report of the financial condition of the association;
- m. Have the accounts examined annually at the end of the school year or upon the change of treasurer by an auditor or auditing committee of not fewer than three members;
- n. Not sign checks for this PTA after the books are closed for audit;
- o. Report the findings of the annual audit to this PTA/PTSA no later than the first general meeting of the new school
- p. Determine the gross receipts for the previous fiscal year and file the appropriate federal tax form(s) with the IRS;
- q. Reconcile the bank statements monthly and have the statements reviewed, signed and dated by a PTA member. This PTA member shall not be related to the treasurer by marriage or any other relationship; and
- r. Perform such other duties as may be provided for by these bylaws, prescribed by the parliamentary authority, or directed by the president, the Board of Directors, or the Executive Committee.

- e. Act in emergencies between meetings of the board;
- f. Make a report at each board meeting; and

g. Appoint delegates and alternates to attend the council PTA meetings, if PTA/PTSA is a member of a council PTA. Section 6. The Executive Committee shall take no action in conflict with any action taken by the general membership or the Board

of Directors.
